Terms of Reference: To enquire into the misconduct of Dr.Srikanta Das, Professor, Department of Plant Pathology, Faculty of Agriculture, BCKV, in the manner of misappropriation/embezzlement of fund in CAAST Project on Conservation Agriculture (a World Bank Project), as per the Articles of Charge labelled against him vide Memorandum No. VC/BCKV/61/972 dated 30.12.2022, and in terms of the provisions laid down under Ordinance relating to Discipline, Penalty and Appeal in respect of the employees of Bidhan Chandra Krishi Viswavidyalaya (BCKV).


The enquiry may be taken up and completed as soon as possible.

The Registrar, BCKV, being the Presenting Officer, will provide the Inquiring Authority with all the necessary documents required for undertaking the enquiry.

The Inquiring Authority shall sit for its meeting on dates and place as and when required and examine documents, as well as call for hearing University officials and staff as decided by her.

All concerned are requested to extend cooperation to the Inquiring Authority for its smooth functioning.

The Inquiring Authority shall submit its report to the Vice-Chancellor, BCKV.
