Intending parties may see the above mentioned non seed items in the said farms on any working day within 7.00 a.m. and 12.00 noon after making prior appointment with the concerned farm Incharge.

1. The rate must be ex-godown and without any container.
2. The rate to be submitted by the party must be written legibly both in figure and in words on a plain sheet duly signed along with detailed mailing address & Mobile No. & photo copy of photo ID proof.

The entire cost of the above as would be offered by the party and duly accepted by the authority will have to be paid to the concerned Incharge against demand draft or cash, within 7 days from the date of acceptance of the tender.
