5. The lease will be provided for the purpose of fish cultivation only.
6. The selected party will not be vested any right of any other operation like irrigation from the pond, cultivation in the dyke, etc.
7. The pond may be used by KVK for demonstration and practical class purposes during exposure visit or farmers visit programme.
8. The selected party has to look after the ponds by their own during the leased tenure. KVK will not be responsible for any theft, loss due to natural calamities, disease pest attack, etc.
9. The selected person or party may follow fish rearing operation such as feeding, treatment of water, etc with the guidance of KVK Scientists.
