DF/BCKV/109/23-24 dt. 18.07.2023 **Re-Tender** is hereby invited from bonafide parties for Lease out of Mango, Coconut, Arecanut, Palm, Jackfruit trees (Only fruits) at RRS, Chakdah farm, BCKV upto **30th June, 2025 (Two Season)**.

RRS, Chakdah farm, BCKV

1. Mango Tree	-	10 Nos.	(only for fruits)	(02 - Big/ 07 - Medium/ 01 - Small)
2. Coconut Tree	-	07 Nos.	(only for fruits)	
3. Arecanut Tree	-	200 Nos.	(only for fruits)	(120 Nos. Big trees with flowering stage + 80 Nos. Small trees)
4. Palm Tree	-	02 Nos.	(only for fruits)	
5. Jackfruit Tree	-	02 Nos.	(only for fruits)	(02 - Small)

1. The rate must be ex-godown and exfarm.
2. The rate to be submitted by the party must be written legibly both in figure and in words on a plain sheet duly singed along with detailed mailing address & Mobile No.
3. The entire cost of the above items as would be offered by the party and duly accepted by the authority will have to be paid to the concerned In-charge against demand draft or cash within 7 days from the date of acceptance of the tender. Otherwise his " Earnest Money / Security deposit will be forfeited.
4. The fruits must be collected by the party at his own cost.
5. Maintenance & cleaning of above mentioned trees and field will be done by the party. Otherwise your tender will be cancelled.
6. Pruning and damaging of branches/ trees of the experimental plants would not be done during harvesting.
