The entire cost of the above paddy as would be offered by the party and duly accepted by the authority will have to be paid to the concerned Incharge against demand draft or cash, within 7 days from the date of acceptance of the tender. Otherwise his " Earnest Money / Security deposit will be forfeited.
4. The non seed paddy must be collected by the party at his own cost.
5. The decision of the authority in any case is final.
