TENDER NOTICE

Tender is hereby invited from bonafide parties for lease out of the ponds for 02 (Two) years from the date of issuance final work order at RRSS Chakdah farm, BCKV under the terms and conditions failing which the tender will be deemed as cancelled and the "Earnest Money/ Security Deposit" will be forfeited.

RRSS Chakdah farm, BCKV

a) Ponds – 02 Nos. (Only for fish Cultivation)
(One Pond - 02 Bigha + One Pond - 12 khata)

(Minimum Book Value for this tender is Rs. 31,000/-)

Intending parties may see the above mentioned ponds in the said farms on any working day within 7.00 a.m. and 12.00 noon after making prior appointment with the concerned farm Incharge.

Each party has to abide by the terms and conditions mentioned hereunder and any breach, abrogation of the same will automatically lead to cancellation of tender and forfeiture of "Earnest Money / Security Deposit".

1. The rate to be submitted by the party must be written legibly both in figure and in words on a plain sheet duly signed along with detailed mailing address & mobile No.
2. The tender along with requisite "Earnest Money" as specified below must be submitted above mentioned ponds within the last date given below.
3. The entire cost of the above ponds as would be offered by the party and duly accepted by the authority will have to be paid to the In-Charge RRSS Chakdah farm, BCKV against demand draft or cash, with in 7 days from the date of acceptance of the tender.
4. A photocopy of Identity card with photograph, such as Aadhaar, EPIC, Driving license, passport etc must be enclosed with tender.
5. The authority may take water from the said pond or may use the water of pond at any time, if need.
6. Erection of hut and cultivation of vegetable at the embankment of the said water bodies is strictly prohibited.
7. Immediately after completion of cultivation of fish from the ponds, the selected bidder has to hand over the ponds to the authority, otherwise his/her refundable security deposit will be forfeited and/or authority can take appropriate action.
8. The decision of the authority in any case is final.

The tender must be accompanied with an " Earnest Money/Security deposit " of **Rs.3,100/- (Three thousands one hundred)** through to be paid against demand draft to be drawn in favor of " BIDHAN CHANDRA KRISHI VISWAVIDYALAYA", payable at PNB, BCKV, or SBI, Kalyani branch or by cash deposited to the cash section of Comptroller , BCKV.
