General Instruction:-

- Admission will be conducted as per Ph.D. Notification No.1/2024-25, dated 30/08/2024 (read with Ref. No. A/Ph.D-12(Part-VI)/L-273, dated 30/08/2024). **During counseling admission will be taken as per ranking and as per availability of seats. For all the seats reservation policy for admission will be followed as per W.B. Govt. norms.**
- **Hostel allotment will be carried out on the same date as per availability.**
- **Candidates failing to attend the counseling as per the above mentioned schedule will not be allowed to take admission. The decision of the Admission Committee for admission will be final.**

- **Venue: Convocation Hall, Administrative Building, Mohanpur, Nadia, West Bengal, India.**
- **Train Route Direction: Nearest Railway Station: Kanchrapara (Eastern Railway). From station by bus (Route No. 22- Kanchrapara to Nagarukhra)/ Auto. **Stoppage-** Mohanpur, **BCKV Main Gate.****
- OR**
- **Bus Route Direction: National Highway 34 (Shiliguri to Kolkata / Kolkata to Shiliguri Bus route), **Stoppage - Barajaguli.** From Barajaguli by Auto/ Toto/ Rickshaw van /Bus to Mohanpur, BCKV Main Gate (Approx 5 minutes)**

- **Candidates are hereby directed to produce the following documents in original and a self attested photocopy at the time of counseling and admission for necessary verification:**
 - (i) Downloaded online application form
 - (ii) Mark-sheets/Grade Cards of Examination: Bachelor's Degree (4-Years Degree Course) [Both Side], Master's Degree (2 years) [Both side]
 - (iii) Age-proof certificate [Birth Certificate/ Admit Card or Certificate of Secondary Examination (10th Standard)].
 - (iv) SC/ST/PwD/OBC-A/OBC-B certificates from the competent authority (for reserved seat).
 - (v) Domicile Certificate issued by competent authority (S.D.O/D.M.).
 - (vi) AADHAAR card of the candidate.
 - (vii) Two (2) copies of recent colour passport size photograph.
 - (viii) Self-attested copy of valid medical certificate from appropriate authority (Sub-Divisional Medical Officer, Superintendent of State Hospital or above category) for person with disability (PwD) candidates.

- **Accreditation Certificate:**
 - For Ph.D. in Agriculture/Horticulture Faculty:** Applicants having Master Degree from other University will have to produce a certificate from appropriate authority mentioning that the concerned Faculty/College/ Programme in the university is either ICAR-accredited or is aided by State/central Government before taking admission/ reporting, failing which his/her candidature is liable to be cancelled.
 - For Ph.D. in Agril. Engineering Faculty:** Applicants having Master Degree from other University will have to produce a certificate from appropriate authority mentioning that the concerned Faculty/ college/ Programme is either AICTE approved or is aided by State / Central Government, before taking admission/ reporting failing which his/her candidature is liable to be cancelled.

➤ **SUBMISSION OF BLOOD ELECTROPHORESIS (THALASSAEMIA) TEST REPORT:**

The candidates are required to submit self attested copy of Blood Electrophoresis (Thalassaemia) test report to the In-Charge, Health Centre, BCKV.

- **ANTI-RAGGING:** Anti-ragging declaration in the form of affidavit duly signed by the admitted candidates and their guardians is to be submitted to the Office of Dean, Students' Welfare after stating of classes. Only after receipt of Anti-Ragging Declaration, the University Registration Certificate would be issued to the admitted candidates.
