Sub: 2nd round Offline Counseling and Admission for Master Degree Programme, 2024-25

In continuation of earlier Notification Vide. No. A/Agril./PG-9/(Part-X)/L-447 dated 13/12/2024 (P.G. Notification No. 7/2024-25), it is notified to all concerned that the remaining vacant seats under Master Degree Programme, which will be available after completion of up gradation round on 27/12/2024, shall be filled up through 2nd round of offline counseling and admission to be held on the same date. List of vacant seats after completion of up-gradation will be published instantly on the spot on 27/12/2024 at the counseling venue, as well as on the University website.

Interested remaining candidates, as per provisional merit list bearing No. A/PG/AG-9/(Part-X)/L-321 dated 10/10/2024 (P.G. Notification No. 3/2024-25), are requested to attend the **2nd round of offline counseling and admission on 27.12.2024 at 01:00 P.M. at Convocation Hall, Administrative Building, BCKV, Mohanpur, Nadia, West Bengal, India.** The interested candidates must reach the venue positively before 01:00 P.M. on 27.12.2024.

General Instruction:-

- Admission will be conducted as per P.G. Notification No.1/2024-25 dated 30/08/2024. **During counseling the candidates shall have to opt the Programme for admission as per ranking and as per availability of seats. For all seats reservation policy for admission will be followed as per W.B. Govt. norms.**
- The non-allotted/ vacant seats of ICAR will be filled up from BCKV UG Pass out students only.
- Candidates who remained absent in 1st round of counselling, will not be eligible to appear in the 2nd round of counselling
- Hostel allotment will be done on the date of admission as per availability of seats.
- **Candidates failing to attend the counseling as per the above mentioned schedule, will not be allowed to take admission. The decision of the Admission Committee will be final.**
- **Train Route Direction:** Nearest Railway Station: Kanchrapara (Eastern Railway). From station by bus (Route No. 22- Kanchrapara to Nagarukhra)/ Auto. **Stoppage-** Mohanpur, **BCKV Main Gate.**

OR

- **Bus Route Direction:** National Highway 34 (Shiliguri to Kolkata / Kolkata to Shiliguri Bus route), **Stoppage - Barajaguli.** From Barajaguli by Auto/ Toto/ Rickshaw van /Bus to Mohanpur, BCKV Main Gate (Approx 5 minutes)

➤ **Candidates are hereby directed to produce the following documents (SELF ATTESTED PHOTOCOPIES IN A-4 SIZE PAPER) & ORIGINAL at the time of counselling and admission for necessary verification:**

- (i) Mark-sheets/Grade Cards of Examination: H.S. Examination (10+2 Standard) / Diploma Course, Bachelor Degree (4-Years Degree Course) [Both sides].
- (ii) Age-proof certificate [Birth Certificate/ Admit Card or Certificate of Secondary Examination (10th Standard)].
- (iii) SC/ST/PwD/OBC-A/OBC-B certificates from the competent authority (for reserved seat).
- (iv) Domicile certificate issued by the competent authority (S.D.O./D.M.).
- (v) AADHAAR card of the candidate.
- (vi) Two (2) copies of recent colour passport size photograph.
- (vii) Self-attested copy of valid medical certificate from appropriate authority (Sub-Divisional Medical Officer, Superintendent of State Hospital or above category) for person with disability (PwD) candidates.

➤ **Accreditation Certificate:**

For M.Sc. (Agriculture/Horticulture): Applicants having bachelor degree from other University or college will have to produce a certificate from appropriate authority mentioning that his/her Faculty/College is either ICAR-accredited or is aided by State Government before taking admission/ reporting, failing which his/her candidature is liable to be cancelled.

For M.Tech. Agril. Engineering: Applicants having Bachelor Degree from other University or college will have to produce a certificate from appropriate authority mentioning that his/her Faculty/ college/ Programme is either AICTE approved or is aided by State Government, before taking admission/ reporting failing which his/her candidature is liable to be cancelled.

➤ **SUBMISSION OF BLOOD ELECTROPHORESIS (THALASSAEMIA) TEST REPORT:**

The candidates are required to submit self attested copy of Blood Electrophoresis (Thalassaemia) test report to the In-Charge, Health Centre, BCKV.

- **ANTI-RAGGING:** Anti-ragging declaration in the form of affidavit duly signed by the admitted candidates and their guardians is to be submitted to the Office of Dean, Students' Welfare after stating of classes. Only after receipt of Anti-Ragging Declaration, the University Registration Certificate would be issued to the admitted candidates.

If any misrepresentation and/or suppression of facts by any candidate gets detected at any stage of physical verification, or at any time through the course of study, his/ her admission would be cancelled.
