❖ **Candidates are hereby directed to produce the following documents (SELF ATTESTED PHOTOCOPIES IN A-4 SIZE PAPER) & ORIGINAL at the time of reporting for necessary verification:**

1. Provisional admission letter along with payment receipt provided after verification of payment of admission fees.
2. H.S. Mark-sheet (both side) & Age-proof certificate (Birth Certificate/Certificate of Secondary Examination).
3. Mark Sheet of Secondary [10<sup>th</sup> standard] Examination /Madhyamik Examination (both side).
4. Certificate of the competent authority (Category – SC/ST/OBC-A/OBC-B).
5. Domicile Certificate issued by the Competent Authority (Chairman, Municipality/ Pradhan, Gram Panchayat /B.D.O./ S.D.O.). In case of residents of Municipality or Municipal Corporation where the elected board has been dissolved and there is no sitting Chairman, the certificate issued by the Executive Officer of the Municipality / Commissioner of Municipal Corporation will also be accepted..
6. AADHAAR CARD and Bank Account details must have to be submitted as per ICAR Rules for USID generation.
7. Valid Medical Certificate from proper authority for physically challenged persons.
8. Passport size Photo (4 copies).

➤ **Following fees to be paid by the admitted candidates on the date of reporting (by cash) :**

- (i) 1<sup>st</sup> Semester fee Rs.6,775/- for Hosteller and Hostel Admission Fee Rs. 3,000/- (refundable)
- (ii) 1<sup>st</sup> Semester fee Rs. 5,275/-for Dayscholar.

➤ **SUBMISSION OF BLOOD ELECTROPHORESIS (THALASSAEMIA) TEST REPORT:**

The candidates are required to submit self attested copy of Blood Electrophoresis (Thalassaemia) test report to the In-Charge, Health Centre, BCKV.

- **ANTI-RAGGING:** Anti-ragging declaration in the form of affidavit (As per attached prescribed format) would be required to be signed by the admitted candidates and their guardians and to be submitted to the concerned Deans of Mohanpur Campus/ Associate Deans (for Burdwan and Bankura Colleges) / Dean Students' Welfare on the date of reporting for classes/ date of reporting for hostel. Only after receipt of Anti-Ragging Declaration, the University Registration Certificate would be issued to the admitted candidates.

➤ **CANCELLATION OF ADMISSION:**

If any misrepresentation and/or suppression of facts by any candidate would be detected at any stage of physical verification, even at any time through the course of study, his/ her admission would be cancelled.
