Sub: Offline Counseling and admission to Doctoral Degree Programme: 2020-21 (1st Phase)

In continuation of earlier Notification No. A/Ph.D-12 (Part-II)/ASS-91 dated 19/10/2020 (Notification No. 1), it is notified to all concerned that the interested candidates and who have already been listed in the provisional merit list for admission to Doctoral Degree Programme in the academic session 2020-21, are requested to attend personally for Offline Counseling and admission as per schedule (**Annexure-I**). *Reservation policy for admission will be followed as per W.B. Govt. norms.* **Candidates failing to attend the counseling as per schedule will not be allowed to take admission.**

The candidate belonging to General and OBC category securing at least **70%** of the 'Total academic mark' and the candidate belonging to **SC/ST** category securing at least **60%** of the 'Total academic mark' (as per provisional merit list) will be eligible for admission in doctoral degree programme, subject to availability of seats.

The other particulars are as follows:

- **Venue:** **Directorate of Extension Building, BCKV, Mohanpur, Nadia, West Bengal, India.**
- **Train Route Direction:** Nearest Railway Station: Kanchrapara (Eastern Railway). From station by bus (Route No. 22- Kanchrapara to Nagarukhra)/ Auto. **Stoppage-** Mohanpur, **BCKV Main Gate.**
- OR**
- **Bus Route Direction:** National Highway 34 (Shiliguri to Kolkata / Kolkata to Shiliguri bus route), **Stoppage - Barajaguli.** From Barajaguli by Auto/ Toto/ Rickshaw van /Bus to Mohanpur, BCKV Main Gate (Approx 5 minutes)
- **Candidates are hereby directed to produce the following documents (SELF ATTESTED PHOTOCOPIES IN A-4 SIZE PAPER) & ORIGINAL at the time of counseling and admission for necessary verification:**
 1. The Mark-sheets/Grade Cards of Examination [Both side]: **Secondary Examination** (10th Standard), **H.S. Examination** (10+2 Standard), **Bachelor's Degree** (4-Years Degree Course) , **Master's Degree** (2 –Years Course) & Age-proof certificate (Birth Certificate/Certificate of Secondary Examination)
 2. Certificate of the competent authority (Category – SC/ST/OBC-A/OBC-B).
 3. Domicile Certificate issued by the Competent Authority (Chairman, Municipality/ Pradhan, Gram Panchayat /B.D.O./ S.D.O.). In case of residents of Municipality or Municipal Corporation where the elected board has been dissolved and there is no sitting Chairman, the certificate issued by the Executive Officer of the Municipality / Commissioner of Municipal Corporation will also be accepted..
 4. AADHAAR CARD and Bank Account details must have to be submitted as per ICAR Rules for USID generation.
 5. Valid Medical Certificate from appropriate authority (Sub-Divisional Medical Officer, Superintendent of State Hospital or above category) **for physically challenged candidates.**
 6. Passport size Photo (2 copies).

➤ **SUBMISSION OF BLOOD ELECTROPHORESIS (THALASSAEMIA) TEST REPORT:**

➤ **ANTI-RAGGING:**

Anti-ragging declaration in the form of affidavit (As per attached prescribed format) duly signed by the admitted candidates and their guardians is to be submitted to the Office of Dean, Students' Welfare after stating of classes. Only after receipt of Anti-Ragging Declaration, the University Registration Certificate would be issued to the admitted candidates.

If any misrepresentation and/or suppression of facts by any candidate would be detected at any stage of physical verification, even at any time through the course of study, his/ her admission would be cancelled.
