Admission will be taken in terms of Notification No. A/Agril./PG-9/(Part-V)/ASS-90 dated 19/10/2020 (Notification No. 1) and as per availability of seats. *Reservation policy for admission will be followed as per W.B. Govt. norms.*

Candidates failing to attend the cancelling as per the above mentioned schedule, will not be allowed to take admission.

1. The Mark-sheets/Grade Cards of Examination [Both side]: **Secondary Examination** (10th Standard), **H.S. Examination** (10+2 Standard), **Bachelor's Degree** (4-Years Degree Course) & Age-proof certificate (Birth Certificate/Certificate of Secondary Examination)
2. Certificate of the competent authority (Category – SC/ST/OBC-A/OBC-B).
3. Domicile Certificate issued by the Competent Authority (Chairman, Municipality/ Pradhan, Gram Panchayat /B.D.O./ S.D.O.). In case of residents of Municipality or Municipal Corporation where the elected board has been dissolved and there is no sitting Chairman, the certificate issued by the Executive Officer of the Municipality / Commissioner of Municipal Corporation will also be accepted..
4. AADHAAR CARD and Bank Account details must have to be submitted as per ICAR Rules for USID generation.
5. Valid Medical Certificate from proper authority for physically challenged persons.
6. Passport size Photo (2 copies).

➤ **SUBMISSION OF BLOOD ELECTROPHORESIS (THALASSAEMIA) TEST REPORT:**
